# Jaishankar meets Xi, reminds SCO of need to combat terror

Raises Pahalgam attack issue, says it was done to sow religious divide

IN HIS FIRST visit to China since the start of the military standoff between Chinese and Indian troops along the Line of Actual Control in eastern Ladakh in 2020, External Affairs Minister S Jaishankar met President Xi Jinping in Beijing Tuesday and apprised him of the "recent development"in bilateral ties - the two countries have begun taking steps to repair relations.

In a post on X after meeting Xi, Jaishankar, who is attending a gathering of Foreign Ministers of the Shanghai Cooperation Organisation in Tianjin, said, "Called on President Xi Jinping this morning in Beijing along with my fellow SCO Foreign Ministers. Conveyed the greetings of President Droupadi Murmu & Prime Minister Narendra Modi. Apprised President Xi of the recent development of our bilateral ties. Value the guidance of our leaders in that regard.

Speaking at the meeting of the foreign ministers, Jaishankar said the SCO was

founded to combat the "three evils" of "terrorism, separatism and extremism", and it was imperative for the SCO to take an "uncompromising position on this challenge".

"The three evils that SCO was founded to combat were terrorism, separatism and extremism. Not surprisingly, they often occur together. Recently, we in India witnessed a graphic example in the terrorist attack in

Pahalgam on 22 April

2025. It was deliberately conducted to undermine the tourism economy of Jammu and Kashmir, while sowing a religious divide. The UN Security Council, of which some of us are currently members, issued a statement that condemned it in the strongest terms and 'underlined the need to hold perpetrators, organisers, financiers and sponsors of this reprehensible act of terrorism account-

tice'. We have since done exactly that and will continue doing so. It is imperative that the SCO, to remain true to its founding objectives, take an uncompromising position on this challenge," he said, referring to Operation Sindoor.

"We meet at a time of considerable disorder in the international system. In the last few years, we have seen more conflicts, competition and coercion. Economic instability is also visibly on the rise.

The challenge before us is to stabilize the global order, derisk various dimensions and through it all, address longstanding challenges that threaten our collective interests," he said.



India, he said, has taken several initiatives in the SCO in domains ranging from startup and innovation to traditional medicine and digital public infrastructure. "We will continue to positively approach new ideas and proposals that are genuinely for our collective good. It is essential that such cooperation is based on mutual respect, sovereign equality and in accordance with territorial integrity and sovereignty of member states," he said, in an oblique reference to China.

"Deepening collaboration within the SCO naturally requires more trade, investment and exchanges. For that to move to the next level, it is imperative that we address some current issues. One of them is the lack of assured transit within the SCO space. Its absence undermines the seriousness of advocating cooperation in economic areas. Another is to ensure the promotion of the International North South Transport Corridor (INSTC). We are confident that it will continue to gather momentum,"he said.

broken into the global top 50, indicating robust graduate employment prospects. Bangalore registered the steepest rise in this dimension, jumping 41 places to rank #59 globally, while Chennai climbed 29 spots, reflecting increasing international recognition of its graduates.

Jessica Turner, CEO of QS,

said India's rise in the 2026 rankings reflects more than a statistical improvement. "As we approach the fifth anniversary of the National Education Policy (NEP) 2020, its focus on global engagement, quality enhancement, and student-centric learning is starting to bear fruit on the international stage. In just ten years, India has seen a 390% increase in the number of universities featured in the QS World University Rankings. That kind of trajectory is rare, and now we're seeing it reflected at the city level too," she said.

The latest edition of the rankings also highlights a broader shift, with a majority of Asian cities climbing in the global standings. This year, 39 cities from the Asia-Pacific region (excluding Australia and New Zealand) were featured, including three newcomers. Among the 34 Asian cities ranked last year, 26 improved their positions in the 2026 edition.

Several Asian cities also achieved their highest-ever rankings, including Seoul (#1), Kuala Lumpur (#12), Beijing (#13), and Taipei (#14), reinforcing the region's growing prominence as a global hub for higher education.

Globally, Seoul has been ranked the world's best student city, overtaking London and Tokyo, which held the top spots in recent years. The United States and United Kingdom continue to dominate in terms of representation, with 16 cities each in the latest rankings.

"Tier-2 and tier-3 cities are at the heart of India's economic transformation. The influx of GCC investments, the local MSME boom, and the government's vision of a Viksit Bharat

are collectively turning smaller cities into serious career hubs," said Nirajita Banerjee, LinkedIn career expert and India senior managing editor.

"This means, for many Indi-

ans, meaningful career progress no longer demands moving to a big city. Because these 10 rising cities offer real opportunities across industries, functions, and roles — right where they are," Banerjee added.

Technology, pharma, and financial services companies are leading this charge. Tech players like Miracle Software Systems (Visakhapatnam), HCLTech (Vijayawada and Madurai), Infosys (Vijayawada), and Datamatics (Nashik) have begun building outposts in these smaller cities, creating new career opportunities close to home. In pharma, companies such as Dr. Reddy's Laboratories, Laurus Labs, and Sun Pharma are expanding in cities like Visakhapatnam and Vadodara. Financial

heavyweights HDFC Bank and ICICI Bank are fuelling local job markets in Raipur, Agra, and Jodhpur. Business development roles are driving hiring in six of the ten rising cities, including Nashik, Raipur, and Rajkot. In tech-forward cities like Visakhapatnam and Vijayawada, engineering positions dominate, while other cities are seeing demand in sales, operations and education.

In fact, the Centre's initiatives are also playing a key role in this decentralisation of opportunity. From Ranchi's smart city transformation to Rajkot's upgraded road connectivity and Chhattisgarh's vision for Naya Raipur, infrastructure upgrades are laying the foundation for local economic momentum.

total formal flexi workforce represented by ISF members to 1.8 million.
